- 2) The Customer shall pay AN £127.00 in respect of the Connect Card ("the Connect Card Charge"). At the end of the Trial Period if the Customer fails to return the Connect Card by 5pm on the 30th day of the trial (or if a non business day the previous business day) the Customer shall be deemed to have entered into a contract for use of the Connect Card for a period of 12 months less the Trial Period upon the terms and conditions of the Agreement.
- 3) If the Customer deactivates and returns the Connect Card to AN by 5pm on the 30th day of the trial (or if a non business day the previous business day), AN will refund the Customer the Connect Card Charge. AN reserves the right to the off the refund against any amount due and owing by the Customer to AN (including but not limited to the Agreement and this Addendum)
- 4) The Customer shall pay the following during the Trial Period: a. an access charge of £20.00 for the duration of the Trial Period b. all data charges incurred by the Customer with the Connect Card. At the end of the Trial Period, if the Customer does not return the Connect Card in accordance with Clause 3 above, the Customer shall pay the Charges in accordance with the Agreement
- 5) The Customer acknowledges that in the event the Connect Card is lost, stolen, damaged, returned incomplete or without original packaging during the Trial Period, the Customer shall forfeit the Connect Card Charge.
- 6) In the event of any inconsistency between the terms of this Addendum and Agreements, the terms of this Addendum shall prevail.
- 7) All other terms and conditions of the Agreements shall remain the same.
- 8) The Promoter reserves the right to withdraw or cancel the promotion at any time in the event of circumstances beyond the control of the Promoter.
- 9) The number of cards made available to the participant is at the Promoter's discretion.
